The teacher will be responsible for not only daily instruction but also to make sure students are receiving the lessons. It is their responsibility to speak with the parents as often as needed but at least once a week."

**RESOLVED FURTHER**, that the Academy during its meetings shall solicit public comments from parents or guardians of the students enrolled at the Academy


