RESOLUTION AUTHORIZING CONTINUED USE OF CREDIT CARD

WHEREAS, the Academy is a governmental body whose purpose is to operate, function, and exist as a public-school academy under the Revised School Code (“Code”), and in accordance with the State Aid Act (“Act”) and the Pupil Accounting Manual (“Manual”); and

WHEREAS, the Board operates the Academy under the terms of a management agreement with Magnum Educational Services (“Magnum”); and

WHEREAS, CHASE Bank previously issued a MasterCard credit card in the name of the Academy, having a maximum credit limit of \$10,000.00; and

WHEREAS, all such uses of the subject credit card are to be made for the benefit of the Academy only, and consistent with the Annual Operating Budget as approved by the Board and as amended from time to time by the Board;

NOW, THEREFORE, BE IT RESOLVED, that the Board hereby confirms and authorizes the continued use of the previously issued credit card, to be use in a manner as permitted by law, and for only the purposes as allowed by the Annual Operating Budget of the Academy; and

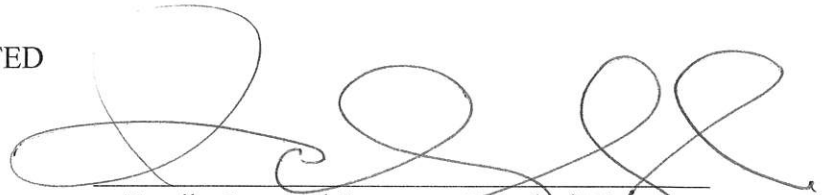
BE IT FURTHER RESOLVED, monthly financial reports from Magnum to the Board should include information and details of the use of such credit card;

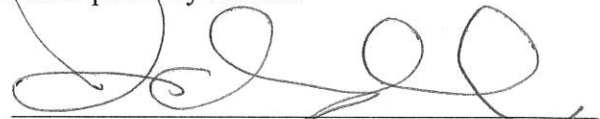
