Data Story Name: Improve Academic Achievement-Mathematics

Initial Data Analysis: Barack Obama Leadership Academy has experienced declining enrollment since 2016 with a current enrollment of 316 students. Data indicates that students are underperforming in both Math and ELA. State standardized testing indicates achievement gaps are more pronounced in Math rather than English Language Arts. Recruiting and maintaining certified instructional staff continues to be a barrier that exists.

Initial Initiative Inventory and Analysis: The Academy's needs assessment revealed that the school was lacking job embedded professional learning in Math. Although some training was provided it was geared towards the implementation of the exsisting Math curriculum and focused primarily on the use of the resource rather than teacher pedagogy.

Gap Analysis: There were zero students proficient in Grades 3-7 on the 2022 Math M-Step. There is a 23.3% achievement gap between our data and the average for Wayne County. Baseline 0% FAY based on 2022 School Index 0/157 (0%) students in grades 3-7 were proficient in Math on 2022 MSTEP.

Statewide - 162,978/489,017 (33.3%) Wayne RESA - 21,685/93,027 (23.3%)

District Data Story Summary: There we no students proficient in Math in 2022. I-Ready data: 18% of students are targeted to meet their typical Math growth level s. The school district is consistently reducing the % of students 2-3 grade levels below in Math.



Math proficiency continues to be a primary concern of the Academy. The lack of certified Math teachers has negatively impacted student performance in Math. Furthermore, there is a need for additional intentional job embedded professional learning and ongoing support for teachers, to improve instructional pedagogy and practices.

During the needs assessment process, the ten dimensions of the Resource Equity Diagnostic were considered as part of the data exploration process. As a result of this work, no resource inequities existed, however opportunities for growth were identified through this work and included in the development of the continuous improvement plan in MICIP.

Analysis:

Root Cause



Five Whys

- Why: Teachers do not have the requisite skills to deliver effective math instruction.
- Why: Teachers have not been provided adequate professional development in math
- Why: Leadership did not prioritize need for professional development in math.
- Why: A 'deep dive' into data was not conducted to determine the need. Leadership changes were a contributing factor.
- Why: There has not been a system in place to review data and develop action plans to address the data.

Challenge Statement: If teachers become effective facilitators of learning, then students will have more opportunities to deeply engage in matematics content, so that student outcomes in Mathematics will improve.

Data Story Name: Improve Academic Achievement - ELA

Initial Data Analysis: Barack Obama Leadership Academy has experienced declining enrollment since 2016 with a current enrollment of 316 students. Although state and local testing data indicates students are performing better in ELA than in Mathematics, our data is still lagging significantly below state and county averages. In addition, local ELA assessment data indicates a large percentage of students are still not achieving expected growth in iReady assessments. Recruiting and maintaining certifed instructional staff continues to be a barrier that exists. A significant portion of instructional staff are not currently certified and teacher/administrative turnover continues to be a concern.

Initial Initiative Inventory and Analysis: The assessing needs process indicated that there has been a lack of job embedded, targeted professional learning for teachers which focuses on the strengthening of instructional pedagogy and skills. There has been some professional learning provided by the publishers of the curriculum resource during the past few months.

Gap Analysis: In 2022, 8.3% of 3rd-7th grade students were proficient on the ELA M-Step. There is a 21.7% achievement gap from between our data and the average for Wayne County. Baseline 8.18% FAY based on 2022 School Index 13/157 (8.3%) students overall were proficient in ELA on 2022 MSTEP. This compares to statewide (40.7%) and countywide (30%) proficiency.


District Data Story Summary: 13 of 157 students were proficienct in ELA in 2022. The lack of certified teachers, turnover and focus on intentional, job-embedded professional learning continues to impact the quality of instruction and overall student outcomes in ELA. During the needs assessment process, the ten dimensions of the Resource Equity Diagnostic were considered as part of the data exploration process. As a result of this work,



no resource inequities existed, however opportunities for growth were identified through this work and included in the development of the continuous improvement plan in MICIP.

Analysis:

Root Cause



Five Whys

- Why: Currently teachers providing ELA instruction do not have the necessary skills to provide effective culturally relevant instruction, especially in the early grades.
- Why: Effective professional development in the area of ELA instruction has not been provided.
- Why: Professional learning has primarily been focused on programs (materials) and therefore has not met the need to enhance teacher pedagogy and skills. A shift has been made recently to provide additional targeted support but has only been in place for the past several months.
- Why: There is a lack of systems needed to determine the needs of BOLA staff to provide effective ELA instruction.
- Why: There is not a comprehensive data system in place to assist in determining needs.

Challenge Statement: If teachers become effective instructional facilitators then students will have more opportunity to deeply engage with effective strategies so that student proficiency in reading and writing will improve.

Data Story Name: Improve Chronic Absenteeism

Initial Data Analysis: From 2016-2020, the percentage of students with on-track attendance was greater than 58%. In 2022 the percentage of students with on-track attendance is 36%. The percentage of students with on-track attendance varies by grade level with the lowest percentage of students on-track in Kindergarten (17.1%) and the highest percentage on-track in 7th grade (84.2%). The percentage of students with on-track attendance in all other grades varies between 31.3% and 40.0% with the exception of 8th grade at 52.6%.

Initial Initiative Inventory and Analysis: There has not been a clearly defined and well orchestrated system in place to address chronic absenteeism. Policies and practices that are in place have not been implemented consistently or with fidelity. In addition, data systems and structures do not currently support regular review, analysis, action planning and follow-up based on attendance data.


Gap Analysis: In 2022, 36.62% of students at Barack Obama had on-track attendance. There is a gap of 55.75% from the state accountability target. Baseline - 36.62% of Barack Obama Leadership Academy students in 2022 had on-track attendance. State target is 92.37%. Statewide Average for on-track attendance for 2022 was 61.5% and the Wayne County average for on-track attendance in 2022 was 51.1%

District Data Story Summary: Attendance: From 2016 -2022, the percentage of students with on-track attendance has not exceeded 38%.

Analysis:

Root Cause





Five Whys

- Why: Prior to the needs assessment work in the Winter of 2023, systems for identifying the scope of the problem through regular review and analysis of attendance data were not in place.
- Why: There has been a lack of personnel with responsibility for monitoring/addressing on-track attendance at the systems level and school leadership did not prioritize transportation or other interventions to address and respond to the problem.
- Why: There has not been enough focus on developing family/community relationships.
- Why: Teacher/leader turnover has impacted the ability to develop closer relationships with families.
- Why: There has not been a system in place to track, assess and address chronic absenteeism.

Challenge Statement: If a schoolwide attendance system is implemented which monitors attendance data to identify students in need then relationships with families can be strengthened, targeted supports can be identified and available resources reviewed, so that families are connected with supports needed to address barriers and improve on-track attendance.

Summary: "School improvement research demonstrates the importance of focusing family engagement around specific outcomes (Bryk et. al, 2010). Authentic family engagement activities are designed so families support and monitor their children's education and behavioral goals through a partnership with schools and community-based agencies. High-quality family engagement is linked to learning outcomes (Mapp, & Kuttner, 2013). Family engagement is strongly linked to higher levels of academic achievement, increased attendance, more positive attitudes toward school, and higher graduation rates (Henderson, & Mapp, 2002). A meta-analysis of over 28 studies investigating the impact of family engagement has found a significant and large association between family engagement and the academic achievement of students from early childhood through secondary school (Jeynes, 2016). Family engagement activities that support high expectations for learners and helping learners make real-world connections are the strongest predictors of achievement (Jeynes, 2005). "
